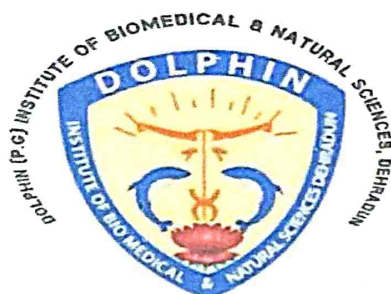

1. **KRCADEPS** having **Krishivan Research Centre** in Dhulkot, Near Daat Kali Mandir, Dehradun to provide practical knowledge on agriculture, horticulture, forestry, environmental and allied related programs. **Krishivan Research Centre** will provide exposure to various practical programs like- Mushroom Cultivation, Apiculture, Medicinal and Aromatic plants cultivation, Forestry, Agroforestry, Horticulture, Floriculture, Nursery Management, Vermicomposting and Organic Farming, Dairy exposure, Environmental programs, Forest Visit, Bamboo Craft, Agroforestry Management to the Students of **DIBNS Forestry, Agriculture & Horticulture, UG & PG.**






