#### VARIATION

The MOU can be amended by a written agreement duly signed by authorized representative of both parties.

## CONFIDENTIALITY

Each party undertakes not to publish or disclose in any manner whatsoever scientific or technical information belonging to the other party which has been received in the execution of the present contract without prior written consent of the other party. This obligation shall apply as long as such information has not become public property. This commitment shall remain in force during 3 years from the date of signature of this contract, notwithstanding the termination or expiry date of the letter.

## INTELLECTUAL PROPERTY

Confidential information shared by a party remains its exclusive property. The sharing of such confidential information can in no way be considered or construed as conferring any property rights or patent license.

## DURATION

This MOU shall commence of the date of its execution by the last Party to sign and shall remain in force for a period of three (3) years. Each Party shall review the status of the MOU at least 2 months before the end of the two-year period to determine whether it wishes the MOU to continue and, if so, whether any modifications are required. The period of validity of this MOU may only be extended by the mutual written consent of both Parties.

# TERMINATION

Either Party may terminate this MOU by giving one month's notice in writing to the other. The termination of this MOU shall not affect the implementation of any specific activities established under it prior to such termination.

# FINANCIALS

All Agriculture training programs will be funded by the candidates either directly or through the collage. Both parties (First and second) shall remain liable for any losses or liabilities incurred due to their own or their employee's actions and neither party intends that the other party shall be liable for any loss it suffers as a result of this MOU.

#### STATUS

This MOU is not intended to be legally binding, and no legal obligations or legal rights shall arise between the parties from this MOU. The parties enter into the MOU intending to honor all their obligations.

## GOVERNING LAW AND JURISDICTION

Both Parties agree that staff and students of either institution engaged in activities under this MOU shall carry out these activities in accordance with all applicable laws and regulations of their respective university and country after full consultation and approval. Any matter arising out of this MOU will be settled at Dehradun Jurisdiction, Uttarakhand only.
